**REQUEST TO PROVIDE FINANCIAL SUPPORT TO THE DEVELOPMENT OF
'GHANA BEYOND AID' CHARTER**

As you are aware, the President's vision of 'Ghana Beyond Aid' is to be developed into a Charter. A Committee which is under the Chairmanship of Hon Yaw Osafo-Maafo, Senior Minister has been established by the President to undertake this assignment. It was inaugurated on 13th June, 2018. The Committee has since commenced work in earnest.

The process of developing the 'Ghana Beyond Aid' Charter involves various activities such as extensive consultations across all the regions of the country, media engagement, public education, international study visits and retreats among others. Furthermore, there are seven (7) Sub Committees which are working concurrently on key thematic sectors such as Agricultural Modernisation, Industrialisation, Human Resource Development, Altitudes/Values of the Citizenry and Infrastructure among others. All these activities have incidental costs estimated at Two Million, Five Hundred Thousand Ghana Cedis (GHC 2.5 million). The Committee wishes to request the Ghana National Petroleum Corporation (GNPC) to assist this process by providing financial support for some of the planned activities. The GNPC has in the past supported key interventions of national relevance.

Among others, the 'Ghana Beyond Aid' Charter Development Committee will seek to explore how our natural resources, including Oil and Gas can be judiciously, effectively and efficiently managed to catalyse our march towards a Ghana Beyond Aid. I am looking forward to discussing how your outfit could provide the needed financial support to the Committee in its work.
